Called to Order:

Deputy Mayor Lenox called the meeting to order at 7:00 p.m. and led the pledge of allegiance.

Approval of Minutes -

A motion was made and seconded (Johnson/Wilson) to approve the October 24, 2024 meeting minutes with changes to the attendance and a change on page 3 paragraph 5. The minutes were approved with a vote of 4 Ayes 1 Absent (Layton).

Commission Member Wilson noted there are vacant lots on either side and the setbacks appear to be in order.

38441 Sandberry St., Delmar, DE, per the attached drawings. A motion was made/seconded (Wilson/Johnson) and carried by a vote of 5 Ayes.
